The June 14th, 2022 Town of Tioga board meeting was brought to order at 7:00pm. Present were Councilman Robert Strong, Councilman Gerald Hyatt, Councilman Drew Griffin, Councilman Paul Welch with Supervisor Lewis Zorn presiding.

Also present were Highway Superintendent Russell Story, Pat Hansen, REAP Rep and Jim Wizer from Tioga Opportunities.

Councilman Strong made the motion to accept the May10th, 2022 Town Board minutes as presented, Councilman Hyatt seconded, carried.

Councilman Strong made the motion to accept the May 3rd, 2022 Planning Board minutes as presented, Councilman Griffin seconded, carried.

Councilman Hyatt made the motion to accept the May reports as presented, Councilman Griffin seconded, carried.

Update from Superintendent Story:

- Hauled about 3,000 yards of gravel from the Owego creek and have a bout a half day of hauling left. Wasn't as much gravel as originally estimated so it is recommended to keep the remaining gravel for the Town.
- Completed paving, now moving on to do some patching then chip seal.
- No delivery date on the loader yet.
- Talked with school Superintendent Josh Roe and he would like to meet with Supervisor Zorn to discuss the fuel for the upcoming fuel contract.
- Received a call about garbage on Wells Rd. Should I give a call to DEC?
 The Board recommended that Superintendent Story call the County Sheriff to report the garbage if he located a name within the trash and asked them if he should notify DEC.

Jim Wizer from Tioga Opportunities performed an energy audit on the Town Hall and presented his findings.

Mr. Wizer recommended the Town Hall have some air sealing done in the ceiling and in the basement. He stated we would see the biggest energy saving benefit if the Town completed this.

Mr. Wizer also stated that heat pumps are the most efficient for heating in the industry currently. He suggested two to three more units with the current heat pump we had would be enough to heat and cool the Town Hall.

The Board stated that the existing 200AMP service the Hall has would also need to have a 100AMP subpanel installed to handle the extra heat pumps.

Jim Wizer stated that an estimate of around \$30,000.00 would complete all the air sealing and heat pump purchases and installation.

The Board requested Mr. Wizer to please provide some estimates for the work of air sealing, heat pump purchase with installation and adding a 100AMP subpanel to the Hall and present them to the Board.

Councilman Hyatt made a motion recommending air sealing, purchasing two heat pumps and adding a 100AMP subpanel to the Town Hall, Councilman Welch seconded, carried.

Supervisor Zorn wants to look into installing a generator at the Town Barn that is similar to the one at the Town Hall.

Supervisor Zorn stated that Armond Vrooman will install the exercise equipment at Ransom Park and that Superintendent Story will provide a man or two to help with the install.

The Board received an offer from Herb Brink to purchase the refrigerator/freezer and the upright freezer located inside the park barn for \$320.00.

Councilman Strong made the motion to keep the refrigerator/freezer and upright freezer, Councilman Hyatt seconded, carried.

Councilman Hyatt would like to know if there is interest in petitioning the County of lifting the 3% tax on fuel oil.
