- Have been removing trees at the ballfield when the guys have time. The Board needs to think about planting new trees/bushes in that area for next year.
- Ayres Rd proposes a liability issue with the deep pits starting next to the road from Lopke's mining. The Town needs to think about abandoning the road starting after the Walker home once all residents have vacated their homes.
- The Freightliner 10 wheeler delivery date has been moved up to first quarter of 2024. If The Town wants to cancel the order it has to do so by January 2023. The Board will make a decision on the Freightliner at the January meeting.
- The 2013 Ford pickup needs \$3,436.15 worth of work from a quote from Royal Automotive to pass inspection. Does the Town want to fix the pickup or think about replacing it with a new one? Superintendent Story provided quotes for a new pickup with an estimate of \$56,000.00 for a Ford 250, \$60,000.00 for a Chevy 2500 and \$50,000.00 for a Dodge 2500. Plow would be an additional \$7,500.00 purchase for any of the trucks. The Dodge is the only make that is available to purchase immediately. The Ford and Chevy would have to be ordered.
